#### **Privacy Policy**

Our Team( "We", "us" or "our" ) pay attention to and are committed to protecting the privacy of our users("you"). This Privacy Policy is meant to explain to you how we collect, use and store your personal data when you use our application (the "Game").

Please read this Privacy Policy carefully to understand our views and practices regarding your privacy. By using the Game Apply, you are agreeing to the terms of this Privacy Policy. #### 1. Date We Collect and How We Collect Date

- 1) When you use the Apply, we may collect non-personally identifiable data from you and it may include, without limitation: (a) The IP and language of device; (b) the type and operator of network; (c) device identifiers(such as IDFA, IDFV); (d) your country; (e) the date and time you access this Apply and the duration of your visit;
- 2) When you use the Apply, we may collect your personal data and it may include, without limitation: (a) your email address;(b) account name; (c) geographic location; (d) game feature uses and preferences and other demographic data that could help identify you.

#### 2. How we use collect your data

1)For security, system integrity (the prevention of hacking, cheating and other improper or unlawful activities), or enforcement purposes;

2)To make sure that we comply with applicable legal requirements.

### 3. Who we share data with

We do not sell, trade or rent your data to others. We work with a variety of third parties and service providers such as third party subcontractors, affiliates of us, retailers, fulfillment partners and marketing partner to help provide you with our Services but we may share data with them to support these efforts. For example, companies we've hired to provide data analytic services may need to collect and access personal data to provide those functions. In such cases, these companies must abide by our data privacy and security requirements, and follow Privacy rules.

#### 4. How we protect your data

In order to protect your personal data held with us and third parties we work with, we use industry-standard physical, procedural and electronic security measures, including encryption where deemed appropriate. # 5. How long do we retain your Data

We will retain your data for as long as is needed to provide you the Service; as long as needed for the purpose it was originally collected for; as long as we are legally obligated; or until we receive a request for erasure. It means that we'll hold your data for the entire life cycle of the respective game you've used as part of our Services. After this point, your personal data will either be erased completely or anonymized for analytical use for a certain period.

6. Applicable Provisions for EU residents

When you are located in the European Economic Area (EEA), you will have following

additional rights:

1) To ask for a copy of your personal data to be provided to them, or a third party;

2) To lodge a complaint about the processing of your personal data with your local data

protection authority in the EEA.

When you are located in the EEA, your personal data will be transferred to recipients in

countries located outside the EEA, which do not provide a similar or adequate level of

protection to that provided by countries in the EEA.

You hereby expressly consent to the transfer of your personal data to recipients, as

described in this Privacy Policy, which are located outside the EEA. You may withdraw your

consent at any time.

7. Protection of Children

We do not knowingly collect personal data about children under the age of 13 (in EEA is

under the age of 16). If a parent or guardian becomes aware that his or her child has

provided us with data without their consent, he or she should promptly contact us and we

take reasonable steps to ensure that such data is deleted from our files.
